Significant projects funded in 2017 include: Rebuild and equip the nature center in the Blackwater Falls SP; Purchase a new swing set in the Blackwater Falls SP playground; Refurbish and upgrade a guest lodge in Bluestone SP; - Purchase a memorial bench in the Coopers Rock State Forest; Improve the hang gliding launch site in Canaan Valley State Park; Purchase a new gas grill and swimming pool equipment in Holly River SP; Purchase energy saving and recycling equipment at Pipestem SP; Purchase lodge improvements at Pipestem SP.
